 - a. Requests related to the adjusting of a lot line. Approvals required include a Variance to transfer an approximate 3,050 sq ft portion of PID 206000053101 to PID 206000053301 and an approximate an approximate 18,240 sq ft portion of 206000053301 to 206000053101. The portions being transferred would result in each resulting parcel being entirely on one side of Knowles Ave NW instead of crossing the road.

Approvals required include Variances to construct a s 24' x 36' single-story detached garage approximately 48 feet from the centerline of a township road (min. 65 ft required) and 22 feet from the top of a bluff (min. 30 ft required) and to raise an existing dwelling located approximately 57 feet from Pleasant Lake (min. 75 ft required) by approximately three rows of block.
